
VOTING INFORMATION

ELECTIONS

On election day, the polls are open from 7 a.m. to 7 p.m. Early voting may take place up to two weeks prior to Election Day at designated locations in each county. Voters must present valid identification (photo ID, signature); otherwise, they must vote a Provisional ballot.

To participate in the primary election of a particular party, voters must be registered in that party. However, if all candidates for an office are from the same party, and will not face opposition in the general election, then all qualified voters may cast a ballot in the primary, regardless of party affiliation.

In the general election, you may vote for the candidate of your choice without regard to political party.

VOTER REGISTRATION

You must register in your county of residence in Florida and you must be:

- * a United States citizen
- * 18 years of age on election day
- * in full possession of your civil rights
- * registered 29 days prior to the election
