# Observer Corps Report on The Escambia Children's Trust

ane Spruill, Mary Louise Winter and Vivian Faircloth, members of the League Observer Corps, reported on the board meeting of the Children's Trust.

Prior to the Board meeting, the Policy Committee approved the procedures and safeguards in place to quickly award grants. The discussion centered on their concern about the position of the Ethics Officer. The committee voted to recommended that the board adopt the Policy Manual with the few minor changes.

Tammy Grier, newly appointed Executive Director, announced she is meeting with all of the board members, as well as individuals in the community, to get input on their views and expectations of the Trust.

In addition to finding office space, Grier wants to spend as little money as possible on administrative functions. She envisions a 'lean and mean' staff including:

- \* Communications Specialist/Board Liaison
- \* Finance Clerk to monitor funds of receiving agencies
- \* Program Director
- \*. Evaluation Manager to measure success or failure of funded programs.

Board members finalized the Policy Manual to include procedures and safeguards in awarding grants, as well as procurement, fiscal policy operations and procedure.

The Board approved a motion to put out a RFP for an analyst to compile all of the needs assessments and data [from local agencies/organizations] and develop a strategic plan for prioritizing them.

### **Observer Corps Needs Your Support**

he Observer Corps is a group of League volunteers who attend government meetings and report back on how the meeting was conducted and what was discussed. Our Observers:

- Make sure the government is following open meeting ("sunshine") laws;
- Promote transparency and accountability in government through regular oversight;

We are currently observing government meetings focusing on education, land use, children's issues and some County Commissioner issues in both counties and are looking to expand coverage of governmental meetings. Stay tuned for our expansion into other topics.

# Bird and Wildlife Protection in the Pensacola Bay Area

#### Does your yard or balcony habitat sustain native wildlife? Keys to Success

lizabeth Major presented an overview of wildlife protection at the March 8th Hot Topics meeting. This was an in-person League meeting and was well attended with members wearing masks.

Elizabeth described Nature as a source of specialized relationships and painted a picture of these interactions. However, today these relationships are in danger.

Only about five percent (5%) of the lower forty-eight states enjoy a pristine ecological standard. The nation has been damaged by logging, plowing, draining, paving, development, as well as, the straightening and damming of rivers and polluting the skies. In addition, hundreds of plants from other countries have been introduced and they compete with native plants.

As result, <u>Keystone</u> insects have drastically decreased in numbers, resulting in the loss of about three billion birds. It is estimated we will lose one million species in the next twenty years.

What can we do to help stop the losses? According to scientist Edward O. Wilson, life as we know it, depends on insects. The resulting chain reaction would be the extinction of flowering plants, changes in physical structures and habitats, and the collapse of food webs, biosphere would rot because of loss of insect decomposers and man would be in trouble!

The evidence clearly shows man is dependent on the natural world. By designing landscapes with a focus on species that contribute to a functioning ecosystem this trend can be reversed.

Elizabeth provided information on using native species in our landscapes, which birds and insects use for food. She identified native plants that sustain wildlife as well as native wildflowers to help build corridors for wildlife dependent on them. The use of yellow outdoor lights provides insect protection since they do not attract bugs.

### **National History Day 2022**

very year the LWVPBA presents prizes at Middle School and High School History Fairs in Escambia and Santa Rosa counties. County History Fairs are an extension of *National History Day*, which annually sends school districts a general theme students must address in their essays, projects, displays, or presentations.

This year's theme was "Debate and Diplomacy in History: Successes, Failures, Consequences." Escambia County's awards ceremony was held February 8th and Santa Rosa's event on February 15th.. Sallie Brown, Shirley Lewis Brown and Charlyle Parrish represented the League, and were pleased to present League metals and monetary awards to three History Fair projects, one in Santa Rosa County and two in Escambia County.

All three projects (which will go on to the state competition) speak to the general topic of "rights," broadly imagined: one about human rights and the right to protest the oppressive British regime in India; one about the early seeds and promise of the women's rights movement in the United States; and another about the right to vote denied through the massacre of at least 50 African-Americans citizens of Ocoee (Orange County), Florida.

#### Our winners are:

Escambia County Junior Division: Sarah Tanveer, for a beautifully executed individual historical paper called "The March to Sovereignty: Debate and Diplomacy in the Nation of India." Sarah is a fine researcher and a very good writer whose paper increased our understanding of Gandhi's "March to the Sea.".

Santa Rosa County Junior Division: Brooklyn Bentley and Brooke Boutwell for their exhibit "The Ocoee Massacre" told a sad story about brave people whose attempts to vote were denied by terrible Klan violence in 1920, more than half a century after the passage of the 15th Amendment. They did extensive research and presented their project to the judges articulately and knowledgeably.

Escambia County Senior Division: Caitlyn Hollingworth, Jessica De, and Mallory Willem for their exhibit "Seneca Falls: Catalyst for Gender Equality." It was not just their exhibit, but their careful and thorough research and their exceptional understanding of the early suffrage movement that drew us to this project. These ladies answered difficult questions with ease and enthusiasm. We ae very pleased that they will attend our May 12 annual meeting, with their exhibit. Don't miss the opportunity to talk to them about their research during the registration period at the beginning of the meeting!
